Sir,

With reference to your application and subsequent discussions you had with us in the interview held on by the selection committee, we have pleasure in offering you an appointment letter in our institution as a Lecturer in the scale of Rs.8000-275-13500. You will join within 15 days. The additional terms and conditions are given as follows:

1. You shall be paid the consolidated amount of Rs. 15000/= during probation period and after confirmation you will get salary as per applicable pay scale of Vinoba Bhave University norms.
2. That your salary / pay will start from the date of commencement of academic session.
3. You will be on probation for a period of two years from the date of joining, if your performance and effectiveness on the job is not found satisfactory your services will be terminated forthwith either during or at the end of the said probationary period without any notice or compensation.
4. After confirmation your services can be terminated by the Institute by giving three month notice or an amount in lieu of that. You can also resign from the services of the institute by giving three month notice or an amount in lieu of that. No balance leave credit to your account at the time of submission of resignation will be adjusted in the notice period.
5. You cannot leave the Institute during session of college i.e. from July to April. If you want to leave the Institute you have to give three month notice before the end of any semester period. (If leaving date from the Institute is 1st July then submission of resignations letter date will be 1st April.)
6. Your service shall be governed by the rules and regulations of the institute / organization which may be in force at the time of your joining or in force or amended from time to time during your service with the institute.
